1 Name of Regulations [see Note 1]

These Regulations are the *Statutory Declarations Regulations 1993*.

2 Definitions

In these Regulations:

Act means the *Statutory Declarations Act 1959*.

address means the place at which, or through which, a person may be contacted, and includes a postal address, but does not include the person's email address.

3 Statutory declaration — prescribed form

- (1) For paragraph 8 (a) of the Act, each of the following forms is prescribed:
 - (a) the form set out in Schedule 1;
 - (b) the form set out in the Schedule to the Act, as in force immediately before the commencement of items 55 and 56 of Schedule 1 to the *Law and Justice Legislation Amendment Act 2004*.
- (2) Paragraph (1) (b) ceases to have effect at the end of 30 June 2006.

4 Persons before whom a statutory declaration may be made

For paragraph 8 (b) of the Act, each of the following persons is prescribed:

- (a) a person who, under a law in force in a State or Territory, is currently licensed or registered to practise in an occupation listed in Part 1 of Schedule 2;
- (b) a person who is enrolled on the roll of the Supreme Court of a State or Territory, or the High Court of Australia, as a legal practitioner (however described);
- (c) a person listed in Part 2 of Schedule 2.

STATUTORY DECLARATION

Statutory Declarations Act 1959

Note 1 A person who intentionally makes a false statement in a statutory declaration is guilty of an offence, the punishment for which is imprisonment for a term of 4 years — see section 11 of the *Statutory Declarations Act 1959*.

Note 2 Chapter 2 of the *Criminal Code* applies to all offences against the *Statutory Declarations Act 1959* — see section 5A of the *Statutory Declarations Act 1959*.

The *Statutory Declarations Regulations 1993* (in force under the *Statutory Declarations Act 1959*) as shown in this compilation comprise Statutory Rules 1993 No. 156 amended as indicated in the Tables below.

Under the *Legislative Instruments Act 2003*, which came into force on 1 January 2005, it is a requirement for all non-exempt legislative instruments to be registered on the Federal Register of Legislative Instruments. From 1 January 2005 the Statutory Rules series ceased to exist and was replaced with Select Legislative Instruments (SLI series). Numbering conventions remain the same, ie Year and Number.
